The RSA, Operators of FC Regina, are dedicated to developing and growing the sport of soccer in the City of Regina through innovative policies, quality programs, financial stability, and access to suitable facilities. ### QUALIFICATION

All directors must:

- (a) be a Member;
- (b) submit to and provide evidence of a clean criminal records check with vulnerable sector authentication satisfactory to the Board.

Directors cannot:

- (a) also be an employee of the Association;
- (b) have a spouse, common law partner or immediate family member who is currently a director or employee of the Association.

### Additional Qualifications

President – must have served one (1) complete year on the Board;

Treasurer – must have a financial background and experience in the area of finances;

Youth Member Rep – must be a parent or coach of a youth player or team

Adult Member Rep – must be a player or coach in the adult league

The nomination deadline is January 4, 2022, at Noon. All nominations must be presented to

and confirmed by the current Board. The final slate of nominees, along with submitted nomination information, will be posted on the FCR website at least two weeks before the AGM on January 20, 2022.

### **Recruitment/Nomination Process**

Board of Director candidates must understand the extent of their commitment and confirm their intent to accept their nomination. Unsuccessful candidates are encouraged to let their name stand for participation in committees of the Board.

The RSA strives for a diverse and knowledgeable Board of Directors. We strongly encourage members from different ethnic groups, genders, and cultures to put their names forward as nominees.
